Hughes Center Research

Many New Jersey residents do not recognize the government benefits they receive, according to a study done by the William J. Hughes Center for Public Policy at Stockton University. Almost 60 percent of pollees denied ever having benefited from the services of a government social program. Yet 68 percent of these respondents had participated in one or more programs. These benefits are often invisible, either because recipients view them as entitlements or because they are delivered indirectly rather than through government bureaucracies.



Survey results suggest that respondents' recognition that they are participating in a governmental social program varies widely by program characteristics and means of implementation. New Jersey residents were most aware of the traditional social support programs targeting the needs of the economically disadvantaged. They were much less likely to identify programs such as Social Security, Unemployment Benefits, Student Loans, or the Home Mortgage Interest Deduction as government social programs. Attitudes and beliefs about such programs can have a noticeable and far-reaching impact, as citizens' political choices are likely to be affected by their perception of governmental social service policy.

Hate Crimes and Terrorism: Danger at Home and Abroad

Brian Levin, a nationally renowned expert on hate crimes and terrorism, spoke to a sizable audience in March, in an event sponsored by the William J. Hughes Center for Public Policy.

Speaking on what turned out to be the eve of terrorist attacks in Brussels, Belgium, Levin noted the constant risks the United States faces from hate crimes and terrorism, both domestic and international.



While he declined to make a prediction about the upcoming presidential election, Levin said in answer to a question from the audience that another terror attack during the campaign would increase the number of people favoring an authoritarian candidate, even if the policies put into place are unconventional and overbearing. Levin also criticized the political climate in which leaders promote strife and conflict by pitting different cultures against each other.

Levin pointed out that there are 40 documented hate groups in New Jersey, and even some local ones, such as the A.C. Skins, which are active in Galloway, Egg Harbor, Atlantic City and Absecon.

Levin is a court-certified expert on extremism in both the United States and the United Kingdom. He has testified before Congress and consulted for state and federal agencies including the FBI and Department of Homeland Security, as well as for universities and civil rights groups.

Levin is the author, co-author and editor of various books, scholarly articles, training manuals and studies on extremism and hate crime. He has written various amicus briefs for U.S. Supreme Court cases, including the landmark case *Wisconsin v. Mitchell*, where he presented criminological data establishing the severity and characteristics of hate crime. Levin is a professor and director of the Center for the Study of Hate & Extremism at Cal State.

College Outcomes Symposium

On June 15, 2016 the William J. Hughes Center for Public Policy at Stockton University hosted the College Outcomes Symposium, a conference designed to explore students' academic success, workforce participation, and civic awareness. The meeting was attended by more than 200 career counselors, academic advisers, admissions counselors and employers from 32 colleges and universities.



Stockton University President Harvey Kesselman was joined on the leadership panel by David Payne, vice president and chief operating officer of Educational Testing Service Global Education Division, and by Hasani C. Carter, the state director of the New Jersey Educational Opportunity Fund (EOF) within the Office of the Secretary of Higher Education. David Payne focused on student outcomes from a global perspective, and stressed ongoing efforts to measure outcomes in a meaningful way for students, educators, and employers. Carter outlined the College Success

Collaborative, an initiative of Secretary of Higher Education Rochelle Hendricks, which involves higher education and community-based organizations.

Darryl Greer, Senior Fellow of the Hughes Center's Higher Education and Strategic Information and Governance (HESIG) project, presented research on student attitudes toward college value and on counseling and advising services. The HESIG research reveals that 30 percent of recent college graduates believe the most important college outcome is to improve career prospects, and one third say colleges are doing extremely well in furthering those aims.

Assemblyman Troy Singleton: Legislator-in-Residence

New Jersey Democratic Assemblyman Troy Singleton visited Stockton University on Tuesday, March 1 as the William J. Hughes Center for Public Policy's Legislator-in-Residence.

Singleton, of Palmyra, N.J., was first sworn into the New Jersey General Assembly on November 21, 2011, in order to complete the unexpired term of Jack Conners. Singleton represents the 7th Legislative District, which includes many municipalities in Burlington County, N.J.



After a tour of the Campus Center, which was jointly conducted by Pedro J. Santana, dean of Students, and John Froomjian, senior research associate of the Hughes Center, Singleton met with student veterans and also with Tom O'Donnell, assistant dean of Students/Veteran Affairs/Leadership, and talked to them about various programs and opportunities available to veterans, relevant legislation, and pressing issues that require immediate attention. Students shared their positive experiences with the variety of services that are provided to student veterans at Stockton. Singleton also had an engaging meeting with members of the Student Senate.

Assemblyman Singleton also participated in Assistant Professor of Political Science Daniel Mallinson's "State and Local Government" class and also sat in on a lecture in "Introduction to American Politics", taught by Assistant Professor of Political Science Claire Abernathy.
