Why is this especially important to understand when working with the children and families of New Jersey?
4. What do you know about the efforts underway in New Jersey to transform child welfare services for vulnerable children and their families?  
How might you contribute toward these efforts as part of BCWEP?

In completing this application, I affirm that the information provided herein is complete, true, and correct, and that I am not in default in payment of any federal educational loan.
