



### **Executive Summary**

Stockton University (Stockton) invites applications for the position of Provost and Vice President for Academic Affairs.

Founded in 1969, Stockton University is consistently ranked among the nation's finest educational institutions and among the top 100 public national universities. Stockton proudly offers the academic, technological and cultural advantages of a large institution combined with the community spirit of a small liberal arts college. Stockton is noted for combining an outstanding interdisciplinary approach to graduate and undergraduate education with all the qualities of an outstanding employer. Stockton offers a unique vibrant working environment, a wealth of work-related opportunities, and outstanding employee benefits. Stockton is committed to attracting, encouraging, and retaining a qualified, diverse workforce to support the mission of the University. The University is located in the Pinelands National Reserve in southern New Jersey, about one hour from Philadelphia, two hours from New York City, three hours from the Baltimore/Washington area, and 20 minutes from Atlantic City. The University's location, stimulating campus life and diverse community make Stockton University a great place to work.

With more than 9,000 undergraduate and graduate students and nearly 700 full-time and part-time faculty members, Stockton offers more than 160 undergraduate and graduate programs in its seven academic schools, as well as continuing education opportunities. Stockton thrives as a distinctive regional institution, providing a diverse, values-based, student-centered environment of exceptional teaching and learning.

The incoming Provost and Vice President for Academic Affairs will serve as Stockton's chief academic officer, supporting the implementation of the University's academic mission and providing curricular and administrative leadership within a collaborative and shared governance environment. The Provost provides leadership to all deans and academic administrators for the purpose of assessing, planning and budgeting the academic enterprise of the campus. Student learning and academic success are at the forefront of priorities for academic affairs, while also supporting research, creative activity, scholarship, faculty and students. Among the Provost's responsibilities will be working effectively with the President and senior leadership to execute the University's strategic plan. The Provost will collaborate with campus leadership to identify and implement transformational initiatives that will further strengthen the University and community.



The Provost will be an engaged, collaborative and innovative leader with a demonstrated commitment to faculty excellence and student success. The Provost will be an institutional advocate and effective communicator with both internal and external constituencies. A strong appreciation of and commitment to Stockton's mission and values is essential. The next Provost should have earned academic credentials that merit appointment as a full professor, including a distinguished academic record in teaching and scholarship/creative activity. A proven record of broad, progressive and substantive academic administrative leadership at the levels leading to a Provost, or a position of similar size and scope will be essential.

### Role of the Provost and Vice President for Academic Affairs

Under the direction of the President, the Provost and Vice President for Academic Affairs will fulfill all of the responsibilities and expectations of Stockton staff as outlined in the University's Policies and Procedures on Staff Evaluation. Specifically, the Provost and Vice President for Academic Affairs shall:

- · Serve as the chief academic officer who sets, supports and maintains the highest standards of excellence for faculty, students and academic programs;
- Promote and support the teacher-scholar model in all ways, including the reappointment and tenure and promotion process;
- Model collaborative decision making and transparency through effective communication;
- Provide leadership and advocacy for all undergraduate and graduate academic programs, administrative units, centers, institutes and personnel within the Division of Academic Affairs;
- Think strategically to enhance existing programs and envision possibilities that promote the development of new academic opportunities;
- Collaborate with other University officers on assessment, including accreditation, compliance and continuous improvement;
- Administer and collaborate in updating relevant University policies and procedures;
- Serve as first among equals on the President's executive staff:

- Provide leadership in executing programs initiated by the Stockton Board of Trustees' 2020 Resolution "Commitment to Diversity, Equity, Inclusion and Social Justice at Stockton" to increase diversity, inclusion, equity and belonging at all levels of the community, faculty, staff and students;
- Serve as a leader in Stockton's commitment to shared governance, including staff and faculty senates, bargaining units and other representative bodies;
- Participate and take a leadership role, along with the President, in representing Stockton to its many external constituencies, including alumni relations and fundraising;
- Provide leadership in strengthening links between the University and local and regional employers for the purposes of internships, clinical and practicum positions and employment opportunities;
- · Perform other duties, as assigned by the President.

### Opportunities and Expectations for Leadership

A first-among-equals member of the University's executive leadership team, the Provost and Vice President for Academic Affairs will be a close partner to President Joe Bertolino in advancing Stockton's strategic priorities and objectives, working in unison with other University officers. In providing such leadership, the Provost will model a commitment to transparency, democratic engagement, openness, and communication and will be expected to:

# Advance Diversity, Equity, Inclusion and Belonging

Stockton University has made progress in efforts to enhance equity among the diversity of faculty, staff, and student populations across the inclusion spectrum; however, there

remain many opportunities to strengthen the institution's Diversity and Inclusion core value. Given the Provost's role in enhancing quality and excellence in the academic arena. the successful candidate will exercise essential leadership by enthusiastically promoting practices that aid in the retention of diverse faculty, staff, and students from all backgrounds; supporting professional development for faculty and staff toward cultural competency and inclusion; and supporting academic programs to infuse diverse perspectives into the curriculum, co-curriculum, and other campus programs and initiatives. The Provost will foster and ensure a safe, inclusive and welcoming environment for all races, religions, socio-economic backgrounds, abilities, gender identities and sexual orientations. The successful candidate will have a fundamental understanding of student demographics and a desire to address the unique needs and concerns of marginalized students. To build trust, the Provost must come from a place of empathy, sensitivity and understanding. Serving as one of the public leaders for advancing diversity, equity, inclusion and belonging, the Provost will maintain a high level of visibility on and off campus, and continually reinforce the importance of this work.

# Support and Promote the Development and Growth of Faculty and Academic Leadership

The Provost must be committed to recruiting, supporting, and retaining a highly qualified, diverse faculty. In a time of resource constraints, Stockton University will need to find the means and strategies to attract new faculty members, assist them in developing a scholarly/creative agenda and obtaining advancement or tenure, while also helping current faculty attain excellence in their instructional and scholarly roles. The University will face similar challenges in attracting new and supporting current staff members who provide academic services. The Provost will lead in a transparent and collaborative manner, helping to build and enhance a sense of trust and community among all who are key to Stockton's success.

After soliciting feedback and input from interested parties, the incoming Provost will serve as a compelling advocate for academic priorities and faculty and work in tandem with a strong cohort of deans to advance teaching, scholarship and service while also ensuring that student success remains a top priority. The next Provost should be a seasoned and collaborative leader with agility, flexibility and socio-cultural and political astuteness to build on the core strengths of the University and help guide the campus as it evolves and changes. The Provost will provide leadership and support for all undergraduate and graduate academic programs, administrative units, centers, institutes, and personnel within the Division of Academic Affairs, including but not limited to the Center for Academic Advising, General Studies, the Honors Program, The Richard E. Bjork Library, the Center for Teaching and Learning Design, Continuing Studies and Adult Education, the Office of Research and Sponsored Programs, the Office of Global Engagementand Student Records and the seven academic schools.

# Support and Promote Community Outreach and Engagement

As an anchor institution in southern New Jersey, and as an expanding university in Atlantic City, it is critically important for Stockton to be involved with the surrounding communities. Stockton's Center for Community Engagement and Service-Learning has developed homegrown programs independent of classes and clubs that enable students, faculty, staff and alumni to become personally involved with our neighbors. In addition, Stockton's fast-growing Service-Learning program provides students with the ability to work with nearby

businesses and community and neighborhood organizations through classroom and co-curricular activities. Through Service-Learning, Stockton's students, faculty, staff and community partners have opportunities to engage in "Service with a Purpose." The Provost will foster these developments and others, such as high school dual credit, continuing education, certificate programs, and the work of the institution's various Centers, to help increase the University's reputation as a regional leader promoting community learning and understanding.

# Foster Commitment to Inclusive Student Success

Stockton's graduation rates are strong, exceeding statewide averages. However, the campus recognizes it must continue to improve in this area. The incoming Provost will be a champion committed to serving students regardless of their preparedness and academic background and will promote a collaborative and supportive environment that provides students with the tools they need to succeed in the classroom, while preparing them for post-graduate success. This requires a deliberate focus on student success strategies and tactics that further increase retention and graduation rates, and close racial equity gaps within the student community. The next Provost will have the opportunity to ensure that campus-wide resources – from facilities, to class schedules, to advising – are in holistic alignment, and support students and faculty for success.





### **Collaborate in Partnership with Shared Governance and Union**

Stockton defines shared governance as "an integrated planning process and a collaborative culture in which Stockton's relevant constituents commit themselves to being partners in accomplishing the University's mission. It functions through a structure that fosters active collaboration, transparency, accountability, understanding and acceptance of compromise, and mutual respect and trust" (Task Force on Shared Governance Summary Report - page 91). Given the importance of shared governance throughout the institution, it will be essential for the Provost to engage and collaborate effectively in a sophisticated shared governance system that includes the Faculty Senate, the Stockton Federation of Teachers (AFT 2275), Communications Workers of America (CWA 1031), Staff Senate and Student Senate.

The Faculty Senate serves as the representative body elected by the Faculty Assembly to provide a faculty voice in the formulation of University policy. Similarly, the Staff Senate serves as the representative body of professional, clerical and custodial staff across divisions to provide a staff voice and the Student Senate provides a student voice. It is important that the Provost understand the role of the Faculty Senate, Assembly, Staff and Student Senates to create opportunities for close collaboration and an informed decision-making process. AFT 2275 represents all full-time and part-time faculty, faculty librarians, and professional staff, as well as Non-Tenure Track Professors (NTTPs) and adjunct faculty members. The Provost

should have knowledge of and experience working in a collective bargaining environment, specifically with union(s) representing faculty and staff.

The Provost co-chaired the Faculty Leadership Task Force formed in September 2018 in recognition that the University had grown in both size and complexity. The next Provost is expected to embrace and promote shared governance, engaging the community in visioning and planning for the future. In doing so, the next Provost will regularly need to utilize principled and transparent decision-making methods to balance carefully the interests of stakeholders while keeping open channels of communication to promote a culture of trust.

### **Support Completion of the 2025 Strategic** Plan and Begin the Next Plan

Stockton's Strategic Plan 2025 Choosing Our Path builds upon essential themes from the University's mission, vision. and values statements, and focuses on inclusive student success; diversity and inclusion; excellence in teaching and learning; strategic enrollment management; financial sustainability; and campus community, communications, and shared governance. Among the Provost's first orders of business will be participation in transitioning from the current strategic plan to take a leadership role in the next planning cycle.

Critical to the Provost's success and the success of the plan will be consistency, predictability and transparency in planning and decision-making. The University community



in general, and the faculty in particular, are enthusiastic to embrace a leader committed to the long term and to coordinating the faculty's aspirations and lived experiences with the senior administration's realities and the board's strategic vision.

### **Professional Qualifications** and Personal Skills

The University seeks an exemplary Provost who will build on Stockton's history and unique strengths and opportunities to reach new levels of success. The University seeks an experienced leader with a record of achievement. The ideal candidate should demonstrate many of the following experiences and qualities:

- Proven ability to listen carefully and to invite and consider the concerns of individuals and groups within the University community

- A genuine curiosity about people and a desire to know their stories and histories to support their humanity and work

- Excellent interpersonal skills and ability to connect with diverse groups, both internal and external to Stockton
- Demonstrated experience building bridges and partnerships across an institution and beyond, with diverse community stakeholders
- Active participation in student life, including participation in student activities and campus-wide events

- A proven record of broad, progressive and substantive academic administrative leadership at the levels leading to a Provost, or a position of similar size and scope
- A record of leading with integrity and transparency and serving as an accessible, visible and engaged leader to inspire the community and build consensus around an innovative vision for the academic enterprise
- A demonstrated commitment to and record of serving undergraduate and graduate students
- Experience in academic personnel administration, policies, and procedures in a unionized environment
- Experience in a professional school environment and in working with interdisciplinary programs

# About Stockton University OVERVIEW

**Stockton University** is ranked among the top public universities in the U.S. with more than 160 undergraduate and graduate programs, as well as continuing education opportunities.

The University, one hour from Philadelphia and two hours from New York City, offers unique living and learning environments throughout southern New Jersey, including the 1,600-acre Galloway campus in the Pinelands National Reserve and Stockton University Atlantic City, located on the Boardwalk, just steps from the beach. Additional locations include Hammonton, Manahawkin, and Woodbine.

As a public university, Stockton provides an environment for excellence to a diverse student body, including those from underrepresented populations, through an interdisciplinary approach to liberal arts, sciences, and professional education. Founded in 1969, Stockton held its first classes in 1971 and recently celebrated its 50th anniversary of teaching. The University's commitment to cultural diversity and its welcoming and vibrant community makes Stockton a great place to learn and work.



### The Stockton Idea

As described by Professor Emeritus Bill Daly in his essay entitled "The Stockton Idea," Stockton was founded with the intention of providing students from lower income and diverse backgrounds with the kinds of experiences that more elite students had been receiving from small, private liberal arts colleges. The Stockton approach was to be built around a unique general studies curriculum, which would provide students with an understanding of the larger landscape of American and global culture and society, beyond what was presented in the disciplines, and which would provide them with the grounding they needed in writing, critical thinking, and quantitative reasoning to succeed throughout their careers after graduation.

The founders eschewed the idea of simply mandating that students take introductory classes in a variety of disciplines, as these would be designed simply to advance students in their majors. Instead, they placed a heavy emphasis upon interdisciplinary courses which would stretch the students and encourage them to synthesize materials from beyond their more narrow disciplinary training. As part of this idea or approach, Stockton committed to having all its full-time faculty, regardless of rank and discipline, engaged in general

studies teaching. This afforded students the opportunity to have greater interaction with faculty members, and it provided the faculty with the chance to stretch themselves beyond their own narrow training.

As a result, Stockton remains a creative educational environment, constantly able to renew itself and respond to the issues of the day. This is seen in the many interdisciplinary minors that have been created such as Women, Gender & Sexuality Studies, Disability Studies, Africana Studies, Migration Studies, and Cannabis Studies, among others, which have grown in response to emerging concerns within the community. Of particular note is the fact that, as a result of its general studies curriculum, Stockton is able to offer more classes and teach more students about the Holocaust and other genocides than any other academic institution in the world (as determined by Yad Vashem—The World Holocaust Remembrance Center, in Jerusalem, Israel).



### **President**

Dr. Joe Bertolino began his role as president on July 1. President Joe, as he is affectionately known, has been a social justice educator for almost 30 years and is passionate about student success and access to higher education.

Since 2016, Dr. Bertolino has led Southern Connecticut State University, a public institution of 9,000 students in New Haven, Connecticut. There, he has pursued several key priorities, including: raising the university's profile; establishing Southern as Connecticut's public university for social justice; expanding community outreach and partnerships, building strategic enrollment and streamlining students' paths to earning a degree.

Prior to joining Southern in 2016, Dr. Bertolino was President of Lyndon State College in Vermont from 2012-2016. From 2004-2012, he held multiple roles at Queens College/ City University of New York, including Vice President for Enrollment Management, Vice President for Student Affairs, Executive Assistant to the President and Chair of the Department of Student Personnel.

He also held the roles of Dean for Community Development, Academic Advisor and Associate Dean for Residential Life at Barnard College in New York from 1996-2004. Dr. Bertolino has taught leadership development classes for undergraduate and graduate students.

Dr. Bertolino has been recognized with numerous outstanding professional awards. He is a member of seven different national honor societies including Omicron Delta Kappa and Golden Key. The American College Personnel Association presented him with the prestigious Annuit Coeptis Award twice as an outstanding new professional and as an outstanding senior professional.

Dr. Bertolino holds a Doctor of Education in Higher Education Administration & Leadership Development from Columbia University; a Master of Social Work from Rutgers University, Camden; and a Bachelor of Science degree in Psychology/ Sociology from the University of Scranton.



### **Cabinet**

The President's Cabinet is comprised of 14 members who oversee the divisional areas of the University and consult the president in their areas of expertise, including Facilities & Operations; Administration & Finance; Enrollment Management; Student Affairs; Information Technology Services; Personnel, Labor & Government Relations; Advancement; Strategic Planning; Diversity & Inclusion; the Atlantic City campus; and General Counsel.

### **Residential Life**

From the quiet beauty of the Pinelands on the Galloway campus to beachfront views in Atlantic City, Stockton's Residential Life offers a variety of housing options. Housing is guaranteed for all four years, and students choose from single, double and apartment-style living. Residential Life assists students in creating a sense of belonging where they can engage with peers, faculty and staff in meaningful dialogue and cultivate personal and professional growth. Residential Life programming focuses on social justice, diversity, equity and inclusion.

### **Career Education & Development**

Stockton's Office of Career Education & Development (CED) prepares students for their life after graduation from

day one. CED assists students with finding internships and jobs, resumes, networking, searching for and applying to graduate programs and career exploration. Upon graduation, alumni retain access to CED's services, and many alumni often return to represent their employers at the biannual Career and Internship Fair.

The Wellness Center encourages the pursuit of healthier lifestyles, balancing study, family, and life commitments – interacting in an environment that fosters positive changes and integrates wellness into the community culture.

The Campus Police is a full-service law enforcement agency with New Jersey Police Training Commission certified State Campus Police Officers.
