One of my most recent and relevant leadership positions at Stockton was chairing the Student Affairs Committee where, alongside other faculty and staff colleagues, I worked on a number of student-related issues such as the BOT Fellowship application process, CARE Referrals, HIPPA Vs. Attendance Policy and others. I currently serve as a member of the First-Year Studies' Program Review Committee (PRC) and share the responsibility of reviewing tenure files for tenure-track/non tenure-track faculty/instructors, mentoring, and advising colleagues applying for tenure/promotion. I also served one term as a member the Faculty Senate Executive Body in 2022; a position that I viewed as a unique opportunity to not only serve the Stockton community, but also to advocate for those fearful of speaking up or unable to share their concerns with the wider university community. For the past few years, I have served on the Compass Fund Review Board where a group of faculty members and staff review and vote on proposals and initiatives seeking financial support from the university. Outside of my responsibilities at Stockton, I preside over the Board of Trustees of FACTS Charter School (in Philadelphia, PA); I also serve as program evaluator for ARTZ Philadelphia, a small arts-based program that works with people living dementia—I am currently working with ARTZ's executive director on a "Guide" for how to do communitybased programing that focus on affirming people's dignity, culture, and individuality. I am confident that some the experiences detailed above on the Student Affairs committee, as a Faculty Senator, a PRC member, and some of the lessons learned as Board Chair of FACTS have adequately prepared me to step in this role and continue to learn how to make Stockton work for every member of its increasingly more diverse community.

Why do you want to be a Senator Officer? What would you bring to this position?

I have been at Stockton since the Fall of 2017. During this relatively short time, I have had the good fortune—really privilege—to work alongside and learn from amazing faculty leaders such as Heather McGovern, Emari DiGiorgio, Donnetrice Allison and others. Each one, in their own way, is an embodiment of the idea of "students first" and a constant reminder that every member of the university community is responsible for making Stockton a better place for all, especially community members from marginalized or targeted social groups who have historically or typically struggle to develop a meaningful sense of belonging at comparable institutions. The same year that I joined Stockton, I received the Council on Anthropology and Education's (CAE) Gaitan Presidential Fellowship. Being a presidential fellow connected me to another community of scholars, mentors, and leaders who individually and collectively—knowingly and unwittingly—truly paved the way for everything that I was fortunate to accomplish as a scholar these last eight years. The leadership education that I received at Stockton and at the CAE showed me what it means to be a community leader truly and fully committed to fighting for "anti-oppressive" and liberatory academic spaces and scholarship for all. I think that it's time for me to give a little more back. I feel ready to be of service to this community and continue the work of some of the leaders who've helped me figure out and carve out my own sense of belonging to the Stockton community.
