Summary: Pool Attendants are responsible for maintaining the highest standards of cleanliness and customer service in all areas in accordance to the company's mission and vision.

Essential Duties and Responsibilities: Include the following. Other duties may be assigned.

- Responsible for keeping the pool area and sun decks clean and clear of debris.
- Responsible for arranging patio furniture inside pool area and sun decks.
- Responsible for hosing down decks, clean windows, vacuum the pool and remove the trash.
- Responsible for the safety of the pool and surrounding areas.
- Responsible for opening and closing the pool.
- Responsible for maintaining the pool and spa temperatures.
- Responsible for maintaining the pool and spa chemicals.
- Responsible for keeping the towel bins neat and supplied with clean towels.
- Responsible for removing soiled towels to the laundry room (located on ground floor).
- Responsible for monitoring occupancy in pool area (92) using In-House report
