Galloway Township, NJ- The Richard Stockton College of New Jersey's Professor of Business Law Audrey Wolfson Latourette was selected by Marquis Who's Who for the 2009-2010 *Who's Who in American Law* and for the 2010 *Who's Who in America* for her activism and dedication.

According to their Web site, Who's Who in America, founded by Albert Nelson Marquis, has provided accurate, concise biographies of notable Americans since 1899.

Professor Latourette has been selected to present her article entitled *Legal Implications of Academic Advising* at the national conference *Challenge as Opportunity: The American Academy in the Best and Worst of Times*. The article is an analysis of the various legal theories related to the student-university contract. The conference, sponsored by New York University, Clark Atlanta University, Morehouse College, and Spelman College, will be held in Atlanta, Georgia from November 19 through November 21. In 2010, the article will be published in NYU's *Network: A Journal of Faculty Development*.

At NYU's special request, a video was filmed, courtesy of the NYU Faculty Resource Network, of Professor Latourette speaking on the benefits of serving as a scholar-in-residence at NYU. The video was posted on YouTube by NYU as a submission to the National Council on Writing in a partnership venture with the Faculty Resource Network.

Professor Latourette's article *Papish v. Board of Curators of University of Missouri: Freedom of Speech in the University*, an invited submission, was recently published by Macmillan Press in the *Encyclopedia of the Supreme Court of the United States*. The article addresses the long history and evolution of First Amendment rights in the university context and the limitations that are imposed by universities.

Professor Latourette is a *cum laude* graduate of Temple University Law School. While earning her degree, she served as Associate Editor of the *Temple Law Review*, and before coming to Stockton, she practiced law with the Philadelphia firm Wolf, Block, Schorr, and Solis-Cohen. Two of Professor Latourette's law review articles have been infused into law school curricula and are utilized in faculty training sessions. The following is a sampling of courses that she teaches at Stockton: Legal and Social Environment of Business, Ethics and Law in Contemporary Society, Perspectives on Women, and beginning in 2010, she will debut a new course that she is designing on education law.
